## Registration: American Stock Dog Registry (ASDR)

- This puppy is sold WITHOUT breeding rights. Spay/Neuter agreement is in effect.
- This puppy is sold WITH breeding rights.

Dirt Road Aussies ("Seller") and the Buyer agree that the puppy described above is a **purebred Standard Australian Shepherd**. The kennel name abbreviation "**DRAS**" **must be included at the beginning** of the puppy's registered name, as chosen by the Buyer.

Registration paperwork will be completed upon finalization of the sale. In the event that registration papers are unavailable at the time of sale for any reason, the Seller agrees to forward the completed paperwork to the Buyer promptly upon receipt.

Dirt Road Aussies will provide all required documentation necessary for registration with the **American Stock Dog Registry (ASDR)**.

### Conditions of Sale:

Dirt Road Aussies requires a **non-refundable deposit of \$100.00** to reserve the puppy described above. This deposit will be applied toward the total purchase price of the puppy.

The puppy will not be released to the Buyer until **full payment has been received in cash at pickup** and the puppy is a **minimum of eight (8) weeks of age**.

In the event that the puppy becomes unsellable or dies prior to transfer of ownership, the Buyer will have the option to select a replacement puppy, if one is available. If a replacement puppy is not available, the Seller will refund the deposit to the Buyer in full.

### Transportation:

Transportation by the Seller may be arranged, with the **first thirty (30) miles to the delivery destination included** in the purchase price. Transportation beyond thirty (30) miles **to the destination only** will be charged at a rate of **\$1.00 per mile**. Return mileage to the Seller's home location is **not included** in the mileage calculation.

Any transportation fees due will be payable in cash at pickup along with any remaining balance.

Dirt Road Aussies will make reasonable efforts to coordinate multiple deliveries when possible and may, at its discretion, **share transportation costs** among Buyers.

Dirt Road Aussies reserves the right to **offer transportation specials or discounts** at any time.

## Adoption Agreement:

If, for any reason, the Buyer is unable to continue caring for the puppy and intends to sell, rehome, give away, surrender, or otherwise transfer ownership of the puppy, the Buyer **must notify the Seller prior to making any such arrangements**.

Dirt Road Aussies reserves the right to **assist in locating a suitable new home** for the puppy. In the event of rehoming or return, **no refund or compensation** shall be provided to the Buyer under this contract. Dirt Road Aussies shall retain the **first right of refusal** regarding any proposed new home or transfer of ownership.

Dirt Road Aussies will accept the return of any puppy sold for the purpose of rehoming the puppy.

If the Buyer fails to notify Dirt Road Aussies of any of the circumstances described above, the Buyer agrees to be **financially responsible for any and all reasonable expenses** incurred by Dirt Road Aussies to recover or regain possession of the puppy, up to a maximum of **\$1,500.00**.

## Health Guarantee:

Dirt Road Aussies guarantees that, to the best of the Seller's knowledge, the puppy is in **good health** and **free from known genetic or congenital defects** at the time of sale. The puppy is guaranteed against **genetic defects** for a period of **one (1) year** from the date of birth.

Should the puppy be diagnosed with a genetic defect within this one-year period, the Seller agrees to replace the puppy with another puppy of **equal value**, when one becomes available. **Color and gender are not guaranteed** for any replacement puppy. Written proof of the genetic defect must be provided by a **licensed veterinarian**.

The puppy will be **current on age-appropriate vaccinations and deworming** as recommended by Dirt Road Aussies' practicing veterinarian. The Buyer will be provided with all related veterinary records at the time of pickup.

The Buyer has **three (3) business days** from the date of delivery to have the puppy examined by a **licensed veterinarian** for a general health evaluation. Failure to complete this examination within the stated timeframe will render this health guarantee **null and void**.

Under no circumstances shall Dirt Road Aussies be held liable for **communicable diseases**.

If the puppy fails the general health examination due to a **genetic or congenital defect**, the Buyer agrees to notify the Seller within **twenty-four (24) hours** of the examination and to provide a **signed written statement from the examining licensed veterinarian** within **forty-eight (48) hours** of the examination.

While every effort is made to prevent minor, treatable conditions (including, but not limited to, diarrhea, coccidiosis, or parasites), it is understood that such conditions are **common and often stress-related**, particularly during transitions to a new environment. These conditions are **not covered** under this Health Guarantee.

## Additional Provisions and Terms of Sale

If a puppy is purchased **without breeding rights**, the Buyer agrees to have the puppy **spayed or neutered no earlier than six (6) months of age and no later than eighteen (18) months of age**.

Until proof of spay or neuter surgery is provided to the Seller, **Dirt Road Aussies shall remain listed as the owner** on all microchip registration information. Upon receipt of written proof of spay or neuter surgery, and provided no other provisions of this contract have been violated, **all microchip ownership information will be transferred to the Buyer**.

If the Buyer fails to complete the spay or neuter procedure within the required timeframe, the Seller **reserves the right to take possession** of the puppy described above.

If the dog is bred without the purchase of breeding rights, the Buyer agrees to pay a **\$2,000.00 liquidated damages fee**.

Should the Buyer later decide to pursue breeding after execution of this contract, the Buyer **must contact Dirt Road Aussies** to purchase full breeding rights for an additional **\$500.00** and execute a **new breeding-rights contract**. Upon receipt of the additional payment and the fully executed contract, Dirt Road Aussies will **immediately transfer all microchip ownership information** to the Buyer.
